Sobha completes first 200 Units of Sobha Dream Acres, Ahead of Time

Bengaluru, July 13, 2016: Sobha Limited, the most trusted real estate developer, has completed first 200 units of **Sobha Dream Acres** project situated at Balagare in Bangalore. The project which is a 1000-crore brand, has set new standards in the industry by completing it 20 months ahead of scheduled delivery, using state-of-the-art precast technology. 

This project is being developed using first in-house precast plant in India that allows building and assembling of modular structures by means of mechanization. Precast is a modern and up-to-date method of construction that uses reusable moulds to cast the concrete. This method is safe, environmental friendly and drastically reduces the number of processes involved in the construction methodology vis-à-vis conventional methods. Precast concrete is highly versatile and is available in a vast variety of different sizes, functions, finishes and colours according to the requirements. Employing this technology has helped reduce delivery timelines and construction costs, making luxury compact housing within the reach of the masses.
