Sub: Provisional attachment order issued by Enforcement Directorate.

We refer to a provisional attachment order issued by the Enforcement Directorate (authority) received today, 7<sup>th</sup> December, 2022.

It pertains to an inquiry conducted by the authority regarding allotment of certain plots being developed pursuant to a joint development arrangement with certain landowners/licensees in Gurugram, in the year 2008.
